The Medical Society of Delaware's new preferred partnership with Presence offers medical practices a quick and easy telemedicine solution. The new telemedicine platform is available to MSD members free of charge until August 30, 2020. Presence can be deployed within five minutes, allows patients to self-schedule, permits HIPAA compliant text and email based communications, as well as audio and or video visits.
