Vaping-Related Lung Illness Takes Life of Delawarean

The Delaware Division of Public Health has confirmed a vaping-related death in Delaware due to severe pulmonary disease. Officials are asking all medical professionals to be vigilant in asking all patients who report e-cigarette product use within the last 90 days about signs and symptoms of pulmonary illness. Medical professionals should report cases of significant respiratory illness of unclear etiology and a history of vaping to the Delaware Division of Public Health, Bureau of Epidemiology (24/7) at 1-888-295-5156. Omnibus Burden Reduction (Conditions of Participation) Final Rule

The Omnibus Burden Reduction (Conditions of Participation) Final Rule removes Medicare regulations identified as unnecessary, obsolete, or excessively burdensome on hospitals and other health care providers to reduce inefficiencies. This rule advances the Patients over Paperwork initiative by saving physicians an estimated 4.4 million hours of time previously spent on paperwork. DHSS Grant Increases Addiction Treatment Among Medicaid Physicians

The Centers for Medicare and Medicaid Services awarded the Delaware Department of Health and Social Services a \$3.58 million grant to increase the treatment capacity of Medicaid physicians. The planning grant will increase addiction-related services through an ongoing assessment of the SUD treatment needs of the state, recruitment, training and technical assistance, and improved reimbursement for and expansion of the number or treatment capacity of Medicaid physicians.
