CMS Takes Action to Lower Prescription Drug Costs

On November 26, CMS published a proposed rule for Medicare Parts C and D that would strengthen negotiations with prescription drug manufacturers to lower costs and increase transparency for patients. The proposed policies for 2020 would ensure that Medicare Advantage and Part D plans have more tools to negotiate lower drug prices, and CMS is also considering a policy that would require pharmacy rebates to be passed on to seniors to lower their drug costs at the pharmacy counter. Medicare Diabetes Prevention Program: Valid Claims

For a claim to be valid under the Medicare Diabetes Prevention Program (MDPP), you must have both the Centers for Disease Control and Prevention preliminary or full recognition (see the Supplier Fact Sheet and CDC website for more information) and a separate Medicare enrollment as a Specialty D1 MDPP supplier (see the Enrollment Fact Sheet and Checklist). Important: If you do not have a separate Medicare enrollment as a MDPP supplier and you submit a claim for MDPP services, your claim will be rejected. Unlike a traditional retirement plan, the non-qualified Deferred Compensation Plan enables employers to select who will participate in the plan, take the deduction during the current year and invest those funds for future distribution with no age restrictions or early withdrawal penalties.
