Surprise Billing – Please Voice Your Concern

A surprise billing compromise between Senate and House committees was announced that would protect patients by limiting their out-of-pocket costs to amounts they would have owed if treated in-network. However, the legislation includes potentially devastating provisions that use a benchmark rate, setting out-of-network payments at the median amount insurers pay for in-network care in order to resolve payment disputes. This compromise appears to benefit insurance companies at the expense of patients seeking a robust physician network. Physicians are urged to call your legislators or use the American Medical Association online action center to send them an urgent message to continue to work to ensure the legislation includes a robust and independent resolution process that treats all stakeholders equally while protecting access to care. Update: Walmart To Delay its Electronic Prescriptions Policy

In an article we shared last week, Walmart announced that it would require electronic prescribing for all controlled substances as of January 1, 2020, with no exceptions. The AMA and multiple medical societies opposed the mandate, urging a delay due to the likelihood for patient harm and how the Walmart policy did not comport with state or federal law.
