QPP MIPS Low-Volume Threshold Criteria for 2019

CMS added a third low-volume threshold criterion for determining Merit-based Incentive Payment System (MIPS) eligibility for 2019. Clinicians and groups are excluded from MIPS if they billed \$90,000 or less in Medicare Part B allowed charges for covered professional services during either of the two determination periods (October 1, 2017 – September 30, 2018, or October 1, 2018 – September 30, 2019), provided care to 200 or fewer Part B-enrolled patients during either of the two determination periods, or provided 200 or fewer covered professional services under the Physician Fee Schedule during either of the two determination periods.
