Known as the Paycheck Protection Program, the initiative provides 100% federally guaranteed loans to small businesses who maintain their payroll during this emergency. DEA Issues Opioid Prescribing Guidance

The U.S. Drug Enforcement Administration (DEA) late yesterday issued guidance to DEA-registered physicians providing new flexibility for physicians managing patients with opioid use disorder. The new guidance permits physicians and other health professionals with a waiver to prescribe buprenorphine for the treatment of opioid use disorder and to issue these prescriptions to new and existing patients based on an evaluation via telephone.
