### FBI Alerts to BEC Scams Targeting COVID-19 PPE Supply

FBI alert warns that hackers are targeting the government and other health care industry buyers attempting to purchase personal protective equipment (PPE) with Business Email Compromise (BEC) scams. A BEC is a sophisticated scam targeting businesses that perform electronic payments, such as wire transfers or automated clearing house transfers. BEC scams have been reported in all 50 states. The fraud campaign is also tied to procurement of medical equipment, such as ventilators, and other equipment and supplies related to the Coronavirus response. Buyers should verify with the manufacturer or distributor that the seller is legitimate for the items offered for sale. The FBI recommends not re-rerouting payments without independent verification that the directions were sent from an authorized party. ### CMS Announces MIPS Credit by Reporting COVID-19 Clinical Data

Clinicians can earn a credit via the Merit-based Incentive Payment System (MIPS) if they participate in a clinical trial and report clinical information on COVID-19. The Centers for Medicare & Medicaid Services (CMS) said that the goal of the new credit is to provide data that will be vital to making treatments to combat the virus. To receive the credit, clinicians must attest to CMS they are participating in a clinical trial on a COVID-19 drug or biologic to treat patients. ### Avet Pharmaceuticals Issues Nationwide Recall

Avet Pharmaceuticals Inc. Issued a voluntary nationwide recall of tetracycline HCl capsules USP, 250 mg and 500 mg due to failed dissolution specifications.
