# Physicians Required to Renew CSR by June 30th

Delaware physicians must renew their controlled substance registration (CSR) by June 30, 2019. Physicians renewing their CSR must attest to the completion of two-hours of education (non-Delaware specific) in the areas of controlled substance prescribing practices, treatment of chronic pain, or other topics related to the prescribing of controlled substances. MSD provides links to CME-related controlled substance prescribing on our website at <a href="https://tinyurl.com/decsrcme.The">https://tinyurl.com/decsrcme.The</a> one-hour Delaware-specific education is not required for CSR renewals and is only required now for new CSR requests.

### MSD Prior Authorization Resolution Accepted by AMA

MSD's submitted resolution requesting the AMA explore emerging technologies to automate the prior authorization process was approved without edits by the AMA Reference Committee and adopted by the AMA House of Delegates at the recent AMA Annual Meeting. This is the first of its kind initiative that MSD has been working to make a reality with the use of block chain technology and other developing technologies. #### **DPH Announces Positive Case of Brucellosis**

The Delaware Division of Public Health (DPH) is reminding Delawareans to avoid consuming raw dairy products as it announces a confirmed case of brucellosis caused by Brucella melitensis. Prior to becoming ill, the patient in this case had consumed unpasteurized homemade dairy products from Mexico. The state's Milk Safety Program, as well as statewide inspections of retail food establishments, are in place to protect consumers from purchasing or consuming raw dairy products, but unlawful distribution may still occur.
