The Medical Society of Delaware (MSD) Annual Meeting is pivoting to a virtual format this year. While we will miss seeing all our exhibitors and sponsors who were able to join us in-person in prior years, there are opportunities to showcase your organization to our members at this year's event.

## **Sponsorship Benefits**

#### 1) Swag Care Package
