The Medical Society of Delaware (MSD) is one of the oldest institutions of its kind in the United States and rich in history. It was founded in 1776 and incorporated on February 3, 1789, twelve days following the date of President George Washington's Oath of Office of the U.S. Presidency. The organization provides its members with resources on physician practice issues, advocacy work, value-based contracting, opportunities for publishing, value-added communications for health care professionals, public and professional education, and so much more.

The first official Annual Meeting of MSD was held in Dover on May 12, 1789, where MSD's first president, James Tilton, MD, was elected. James Tilton, MD became a crusader for sanitation and established the first isolation wards for contagious diseases, observations he learned while serving as Regimental Surgeon during the Revolutionary War and afterwards in the War of 1812. In 1813, Dr. Tilton was appointed the first Surgeon General of the U.S.

The beginnings of MSD and the period of time during which it was created were "under difficult and discouraging circumstances; the roads were wretched, the means of travel uncomfortable, and hotels anything but luxurious. The purpose of the Society was for the mutual improvement and to advance the knowledge of medicine for the benefit of mankind."

Although times have changed since the beginnings of MSD, the similarities remain: physicians continue to face difficult and discouraging circumstances and our focus continues to be helping physicians to better serve the patients in our state.
