\$100 Million CARES Act Fund Will Support DE Health Care Professionals

Governor John Carney and the Delaware Department of Health and Social Services announced this week, the creation of a Health Care Relief Fund to support Delaware health care professionals through the COVID-19 crisis. The \$100 million fund will support health care professionals throughout the health care industry that have been on the front lines fighting COVID-19 in Delaware. Funding from the Health Care Relief Fund can be used to support COVID-19 related investments, including technology upgrades, purchases of personal protective equipment (PPE), and environmental modifications in health care facilities. National Prescription Drug Take-Back Initiative

On Saturday, October 24, 2020 from 10 a.m. to 2 p.m., the Delaware State Police has partnered with the Drug Enforcement Administration (DEA) to schedule their National Take-Back Initiative (NTBI). This is a great opportunity for those who have accumulated unwanted, unused, and expired prescription drugs, to safely dispose of those medications. This is an opportunity to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs. The service is free and anonymous, no questions asked. DEA will also accept vaping devices and cartridges at any of its drop off locations during Take Back Day. It is important to note that the DEA cannot accept devices containing lithium ion batteries. If batteries cannot be removed prior to drop-off, DEA encourages individuals to consult with stores that recycle lithium ion batteries. For more information Visit https://tinyurl.com/PDTB2020.

Reminder: 2021 Controlled Substance Registration Renewal

Delaware physicians holding a Controlled Substance Registration (CSR), will be required to renew by **June 30, 2021**. All practitioners who apply for a Delaware CSR, must complete a mandatory two-hour, two part course pertaining to safe prescribing and distributing of controlled substances, treatment of pain, and recognizing and treating opioid use disorder. **This is the ONLY approved course for meeting the CSR renewal requirement**. Practitioners initially issued a CSR for a period less than two years do NOT need to repeat this course in that initial licensure period. All other CSR holders must complete this course to meet the two-hour continuing education requirement each renewal cycle. Visit https://tinyurl.com/dprmandatory
