Nationwide Recall of Dexmedetomidine Hydrochloride Injection

Fresenius Kabi USA is voluntarily recalling a single lot of Dexmedetomidine HCl in 0.9% Sodium Chloride Injection, 200 mcg/50 mL (4 mcg/mL), 50 mL fill in a 50 mL vial. DPH COVID-19 Vaccination Playbook

The Delaware Division of Public Health (DPH) has released its COVID-19 Vaccination Playbook, which lays out how it expects to navigate the distribution of the COVID-10 vaccine. Due to an expected shortage of the vaccine, Delaware plans to make the two-shot series available in a multiple step approach by prioritizing population groups starting with persons serving in health care settings who have the potential for direct or indirect exposure to patients or infectious materials. The Telehealth Modernization Act of 2020 (H.R. 8727/S. 4375) would lift the rural-only restriction and add any site where a patient is located as a potential originating site. The Delaware Health and Social Service would like to make you aware of an additional funding opportunity that opened under the Health Care Relief Fund program. This program is targeted to health care industry professional and trade organizations and aims to help them support their membership as they adjust to delivering services during the pandemic. The application is due on November 30th. Applicants will need to submit a signed application, signed certification, a line-item detailing proposed expenditures, and a 12-month financial statement listing the applicant's CY 2019 operating budget. Applicants will be required to attest that they reviewed the U.S. Treasury Department guidance, will use received funds for acceptable expenses as defined in those documents, and as well as to attest to legal terms and conditions.
