DPH Releases Updated COVID-19 Vaccine Enrollment Instructions

The Delaware Division of Public Health (DPH) is strongly recommending that medical practices go through the process of registering to be a COVID-19 vaccinator, regardless of whether the intention is to vaccinate. Being enrolled will allow small practices to have the option to vaccinate their own staff once the vaccine becomes available. The process to enroll can take time, so it is important not to delay. DPH Announces Arrival of the Pfizer COVID-19 Vaccine

With the recent FDA authorization for the emergency use of the first COVID-19 vaccine, the Delaware Division of Public Health announced that Delaware received an initial shipment of 975 doses of the Pfizer BioNTech COVID-19 vaccine on Monday, 12/14 and an additional 7,800 doses on Wednesday, 12/16 for a total of 8,775 doses of the vaccine this week. Delaware Begins COVID-19 Vaccinations in Long-Term Care Facilities

Governor John Carney and the Division of Public Health announced that Delaware is among the first states in the nation to begin vaccinating staff at long-term care facilities. Residents will be able to begin receiving the vaccine the week of December 28, as part of vaccination efforts under the federal pharmacy program. Walgreens and CVS pharmacists are partnering with facilities to vaccinate residents. While the vaccine is shipped directly to the pharmacies from the federal level, doses come out of each state's total allocation. Residents at long-term care facilities account for 1,736 of the state's 47,929 positive coronavirus cases as of December 11. Long-term care residents account for 455 of the state's 833 coronavirus deaths, slightly more than half, as of December 11. Visit https://tinyurl.com/covidvaccinelongtermcare.

FDA Authorizes Emergency OTC Rapid At-Home COVID-19 Diagnostic Test

The FDA has issued an emergency authorization for the country's first coronavirus test that can run from start to finish at home without the need for a prescription. Individuals as young as 2 years old are cleared to use the test. Unlike many similar products, which are only supposed to be used by people with symptoms of COVID-19, this test is authorized for people with or without symptoms. Clinical Outreach & Community Activity Webinar

The Center for Disease Control and Prevention (CDC) held a Clinical Outreach and Communication Activity (COCA) webinar this week to outline the Vaccine Adverse Event Reporting System (VAERS). VAERS, co-managed by the CDC and FDA, is the nation's early warning system for vaccine safety, covering 320 million US residents.
