#### **Cyber Insurance Alert**

The cyber insurance marketplace has been changing dramatically over the last few months. Frequency and severity of ransomware events have impacted the market causing dramatic rate increases as well as mandating safety requirements for current and new placements of coverage. The Medical Society of Delaware Insurance Services, Inc. (MSDIS) team has seen a significant increase in the number of current insureds who are missing several key safety measures. Carriers are placing surcharges of up to 25% onto rates if these key safety measures are not in place in your practice.
