DHSS Order to Provision of 2nd Doses of COVID-19 Vaccine Requirements

The Delaware Division of Public Health (DPH) has issued a health update to advise the health care community and vaccination providers enrolled to administer COVID-19 vaccinations, of a newly signed DHSS order with requirements regarding administration of second doses of a COVID-19 vaccine. Failure to comply may result in a fine, repeated failure to comply may result in cessation of vaccine distribution to the non-compliant provider. The State of Delaware and Federal Emergency Management Agency announced that appointments are open for individuals who received their first COVID-19 vaccine dose 35 or more days ago from a pharmacy, medical provider, clinic or other source in Delaware and have not yet obtained a second dose. Medicaid Training Program to Treat Opioid Use Disorder

The Delaware Department of Health and Social Service (DHSS) invites physicians and practice managers in primary care, women's health, infectious disease and psychiatry to participate in a program that will train how to treat opioid use disorder (OUD) among Medicaid recipients. Office-Based Opioid Treatment (OBOT) involves prescribing safe, effective, FDA-approved medications, especially buprenorphine, to treat OUD in primary care and other outpatient settings. The OBOT Fellowship Program helps practices design and implement clinical and operational workflows to use medications to treat OUD.
