Delawareans Will Have New Opportunity to Gain Health Insurance

Delawareans looking for affordable health insurance will have an additional opportunity to sign up for coverage – including tax credits for eligible enrollees that help to reduce monthly premiums significantly from Feb. 15 to May 15 on HealthCare.gov, the federal online Health Insurance Marketplace created by the Affordable Care Act (ACA). Attest to the 2020 Medicare Promoting Interoperability Program by April 1

The Centers for Medicare & Medicaid Services (CMS) reminds all Medicare Promoting Interoperability Program participants that the deadline to submit 2020 data is **April 1**, **2021** at **11:59 pm ET**. Non-Opioid Pain Management Toolkit Evaluation Survey

Approximately 1,500 providers received "Non-Opioid Approaches for Managing Chronic Pain: A Toolkit for Providers" from the Delaware Department of Health and Social Services, Division of Public Health (DPH) in March 2020. The toolkit, developed by DPH, shared comprehensive, evidence-based non-opioid pain management resources so that patients can receive non-opioid pain management options. Opioid prescribing should not be the first or only choice to treat chronic pain. DPH is conducting a review of this outreach effort. Instructions for Sales in Medical Facilities

Hospitals and physician's offices may request a waiver from the Division of Public Health (DPH) to allow business contacts such as medical sales associates or non-essential deliveries to enter their medical facilities. The waiver request must be submitted to DPH. Business contacts such as medical sales associates and non-essential deliveries will not be permitted in medical facilities, including hospitals and physician's offices, without DPH waiver approval.
