# Tell Congress To Vote Yes On H.R. 1868 & Provide Relief To Physicians

If Congress doesn't act by March 31, the Medicare payment sequester will take effect, triggering a devastating cut for physician practices across the country. Recently, legislation was introduced in the House that would protect physician practices by extending the current Medicare sequester moratorium beyond the March 31 deadline. # Medicare Payment Increase for COVID-19 Vaccine

The Centers for Medicare & Medicaid Services (CMS) has increased the Medicare payment amount for administering the COVID-19 vaccine. Effective for COVID-19 vaccines administered on or after March 15, 2021, the national average payment rate for physicians, hospitals, pharmacies and many other immunizers will be \$40 to administer each dose of a COVID-19 vaccine. This represents an increase from approximately \$28 to \$40 for the administration of single-dose vaccines, and an increase from approximately \$45 to \$80 for the administration of COVID-19 vaccines requiring two doses.
