Delaware Unemployment Scams

The Medical Society of Delaware has learned of several Delaware Department of Labor (DOL) Unemployment Insurance issues, including identity theft. MSD has been notified that scammers may target physicians and their staff. The DOL is aware of these issues and working diligently to resolve. Physicians may receive Separation Notices from the DOL for employees who have NOT filed an unemployment claim, and may actually still work for your practice. The notice lists the employee's correct Social Security number and Reason for Separation. The employer is required to verify the employee's dates of employment and reason for separation. It's very important to promptly respond to the Notice as there is a deadline. Scammers may also use tax I.D. numbers and specific practice information.

Employees may receive a notice from the DOL stating that they qualify for a certain amount of money per week in unemployment benefits, or they may receive a Form 1099-G for 2020 for Delaware unemployment benefits they did not receive. DPH Expands Vaccine Eligibility to Persons With High and Moderate Risk

This Division of Public Health (DPH) had issued a Health Alert to advise the medical community to prepare to vaccinate individuals with high and moderate-risk medical conditions for COVID-19. In moving to vaccinate more eligible persons, the state and DPH expanded vaccine delivery to patients aged 16-64 with conditions that increase the risk for severe illness from SARS-CoV-2.
