CMS Interoperability and Patient Access Final Rule

The Interoperability and Patient Access final rule (CMS-9115-F) put patients first by giving them access to their health information when they need it most and in a way they can best use it. This final rule focused on driving interoperability and patient access to health information by liberating patient data using CMS authority to regulate Medicare Advantage (MA), Medicaid, Children's Health Insurance Program (CHIP), and Qualified Health Plan (QHP) issuers on the Federally-facilitated Exchanges (FFEs). Recognizing the challenges faced by payers during the COVID-19 public health emergency, CMS exercised enforcement discretion for the Patient Access API and Provider Directory API policies for MA, Medicaid, and CHIP effective January 1, 2021. Pause Lifted on Johnson & Johnson Vaccine

After reviewing vaccine safety data, the Centers for Disease Control and Prevention (CDC) and the Food and Drug Administration (FDA) recommended last week to lift the pause on the use of the Johnson & Johnson Janssen single-shot vaccine. The FDA determined that the available data show that the vaccine's known and potential benefits outweigh its known and potential risks in individuals 18 years of age and older. At this time, the available data suggest that the chance of blood clots and low platelets, also known as thrombosis-thrombocytopenia syndrome (TTS), occurring is very low, but the FDA and CDC will remain vigilant in continuing to investigate this risk.

You have more time to submit your NHSC Loan Repayment Program application. The deadline to submit applications for the National Health Service Corps (NHSC) Loan Repayment Program is extended until Thursday, May 27 at 7:30 pm ET. For more information visit https://tinyurl.com/3vrvn8yj.

Medicare FFS Claims: 2% Payment Adjustment Suspended Through December

The CARES Act suspended the sequestration payment adjustment percentage of 2% applied to all Medicare Fee-for-Service claims from May 1 - December 31, 2020. The Consolidated Appropriations Act, 2021, extended the suspension period to March 31, 2021. An Act to Prevent Across the Board Direct Spending Cuts, and for Other Purposes, signed into law on April 14, 2021, extends the suspension period to December 31, 2021. Medicare Administrative Contractors will release any previously held claims with dates of service on or after April 1 and reprocess any claims paid with the reduction applied. Open Payments Pre-publication Review and Dispute Now Available

Pre-publication review and dispute for the Program Year 2020 Open Payments data is available now through May 15, 2021. The Centers for Medicare & Medicaid Services (CMS) will publish the Open Payments Program Year 2020 data and updates to the previous program years' data in June 2021. COVID-19 Vaccine: Check Medicare Eligibility

Medicare eligibility can now be checked for COVID-19 vaccine administration history from Fee-for-Service claims paid for calendar years 2020-2021. You can get the following eligibility information for each paid vaccine administration claim: CPT or HCPCS codes, Date of service, and National provider identifier for who administered the vaccine.
