Updated Instructions For Business Contacts Entering Medical Facilities

Effective April 21, 2021, hospitals and physician's offices are no longer required to request a waiver from the Division of Public Health to allow business contacts to enter these medical facilities. Business contacts, such as medical sales associates and non-essential deliveries, are permitted in medical facilities at the facility or office's discretion. DPH Survey on COVID-19 Vaccine for 12 to 15-Year-Olds

Are you the parent of a 12 to 15-year-old? The Delaware Division of Public Health (DPH) wants to hear from you! The FDA has expanded authorization of the Pfizer-BioNTech coronavirus vaccine for this age group, showing a high antibody response from the vaccine and 100% protection against the virus. DPH wants to gauge the willingness of parents to get their children vaccinated. The survey is anonymous and should take five minutes or less to complete. DPH Opens New Standing Vaccination Clinics In Four Locations

The Delaware Division of Public Health has opened four standalone COVID-19 vaccination clinics this week, which will serve for the next several months as an option for people to be vaccinated with or without an appointment, including those in the newly eligible 12-and-older age group. These clinics use Pfizer vaccine and can immediately begin vaccinating the 12+ age group. The vaccination clinics will schedule appointments or accept walk-ins Monday through Friday between 8:30 and 11:30 am and 1:15 and 4:00 pm. Deadline approaching: Apply for PCF by May 21

The deadline to apply for the second cohort of the Primary Care First (PCF) model is next Friday, May 21, 2021. The Centers for Medicare & Medicaid Services (CMS) previously released a request for applications for its second cohort of the alternative payment model (APM), set to begin in January 2022. CMS has indicated that practices selected to participate will be notified in summer or fall 2021, and onboarding will occur during the last quarter of the year. The first PCF cohort began in January 2021, and the model will qualify as an advanced APM in both 2021 and 2022. For more information visit https://tinyurl.com/43czybsa.

Congress Needs to Act on Telehealth

Recently, legislation was introduced in both the House and Senate that, if passed, would make the expanded access to telehealth services permanent. The Telehealth Modernization Act of 2021 (H.R. 1332/S. 368) would lift the rural-only restriction and add any site where a patient is located as a potential originating site and ensure all Medicare beneficiaries may receive covered Medicare telehealth benefits, including at home and via mobile technologies as appropriate, while the CONNECT for Health Act (H.R. 2903/S. 1512) would provide HHS with permanent authority to waive these restrictions, similar to the authority the agency has for the duration of the COVID-19 public health emergency.
