Telehealth Legislation Signed By Governor

The Telehealth Access Preservation and Modernization Act of 2021 (House Bill 160) was signed by Governor Carney on Wednesday and will enhance Delawareans' access to telehealth and telemedicine services through the adoption of the Interstate Medical Licensure Compact. The Act consolidates the existing law relating to telehealth applicable to all health care providers authorized to practice telemedicine and makes permanent the telehealth flexibilities put in place for the COVID-19 pandemic. Last Call - Controlled Substance Registration Renewal

The Controlled Substance Registration (CSR) biennial renewal deadline is June 30, 2021. As a condition of CSR renewal, completion of the Delaware Division of Professional Regulation mandatory two-part continuing education course every two years is required by those who prescribe controlled substances. This course satisfied the renewal requirement. CSR renewal must be completed through the DELPROS system at https://delpros.delaware.gov/OH_HomePage. FDA Warning On Innova COVID-19 Rapid Antigen Tests

The Food and Drug Administration (FDA) issued a warning to the public to stop using rapid COVID-19 antigen tests developed by Innova Medical Group. This warning follows a Class I recall for significant concerns about the test's accuracy. The test has not been authorized or approved by the FDA for use in the US, however, investigators found the test was being sold and distributed. Employee Retention Tax Credit Support Program

The Employee Retention Tax Credit Support Program (ERTC) is being offered through the Delaware Small Business Development Center and can mean a tax credit to businesses of up to \$5,000 per employee (for year 2020) and up to \$7,000 per employee (per quarter of 2021). The ERTC program is available to any for-profit or non-profit employer with 10-50 employees that experienced significant reduction in gross receipts or full or partial suspension in operations with a more than nominal impact.
