Delaware's Public Health Emergency Extended

Governor John Carney on Wednesday formally extended the Public Health Emergency order another 30 days to allow the State of Delaware and medical providers to continue COVID-19 vaccination and testing programs. COVID Vaccine and Testing Updates for Long-Term Care & Health Care Facilities

Governor Carney and the Delaware Department of Health and Social Services announced that beginning on **September 30**, staff in long-term care and other health care facilities will be required to provide proof of vaccination or to undergo regular testing to prevent the transmission of COVID-19 to vulnerable populations. Flooding Causing Prescription Delays At Walgreens Pharmacies

Some Delaware Walgreens pharmacies have been temporarily unable to fill prescriptions or provide COVID-19 tests. The vendor that manages internet, phone, and computer servers for Walgreens has been impacted by Hurricane Ida. According to a Delaware Department of Health and Social Services Facebook post (https://tinyurl.com/bftr43vr) COVID-19 testing is closed until further notice at all Delaware Walgreens. Some Walgreens are able to process prescriptions. Please call the store ahead to ensure it can be processed. If a COVID-19 test is needed, please visit de.gov/gettested.

Over 400 CPT® Code Changes Announced for 2022

The American Medical Association (AMA) released updates to the 2022 Current Procedural Terminology code set with many aligned to new technology services and COVID-19 vaccine administration. Of the 405 changes, there are 249 new codes, 63 deletions, and 93 revisions. There are a series of 15 vaccine-specific codes for reporting and tracking immunizations and administrative services against the coronavirus. DPH Announces First Human Case of West Nile Virus

The Division of Public Health (DPH) announced that a 69-year-old Kent County man was infected with West Nile Virus (WNV), the state's first case of human WNV since 2018 when 10 human WNV cases were reported, including two deaths from the illness. Delawareans are reminded that the possibility of contracting mosquito-transmitted diseases will continue until colder autumn temperatures arrive in mid-October or later.
