Governor Carney formally extended the Public Health Emergency

Governor Carney formally extended the Public Health Emergency order another 30 days to allow the State of Delaware and health care professionals to continue COVID-19 vaccination and testing programs. Under Delaware law, Public Health Emergency declarations must be renewed every 30 days. The Governor encouraged getting COVID-19 vaccinations and boosters when eligible, as well as receiving a flu shot to prepare for this year's flu season. Delaware Monkeypox Testing Frequency Change

Due to the continued decrease in global cases of monkeypox and requests to test at the Delaware Division of Public Health (DPH) Laboratory, the Delaware Public Health Lab (DPHL) will begin batching and reporting tests to Monday, Wednesday, and Friday beginning October 17, 2022. Request to test and submission time will be for 12:00 p.m. on Monday and Wednesdays, and 1:00 p.m. on Fridays.

The 20th National Prescription Drug Take Back Day will be held on **Saturday, October 29th from 10 am -2 pm** The initiative aims to provide a safe, convenient, and responsible means of disposing of prescription drugs, while also educating the general public about the potential for abuse of medications. Mandatory Reporting Training for Medical Professionals for Year 2023

Delaware law requires that, in order for medical professionals to renew their license, they must attest that they have completed training on 1. how to recognize child sexual and physical abuse, exploitation, and domestic violence, 2. your reporting obligations under the Medical Practice Act and Regulatory Provisions Concerning Public Health. The 2023 Mandatory Reporting Training for Medical Professionals (https://tinyurl.com/paku7cc8) will be available on January 1, 2023. Licensed physicians must take the 2023 Mandatory Reporting training even if they recently completed mandatory reporting training. This training must be completed before every medical license renewal.
