#### **Tell Congress: Cancel Medicare Physician Payment Cut**

If Congress fails to act by the end of the year, physician Medicare payments are planned to be cut by 4.5% in 2023. Please take a moment and contact your Senators and Representatives to tell them to cancel the cuts to protect physician practices and preserve patient access to care. The evidence is clear: The Medicare payment system is on an unsustainable path threatening patient access to physicians.

#### **CMS Aims to Overhaul Prior Auth Under Proposed Rule**

The Centers for Medicare and Medicaid Services (CMS) released the Advancing Interoperability and Improving Prior Authorization Processes Proposed Rule that would place new requirements on Medicare Advantage (MA) plans, state Medicaid and Children's Health Insurance Program (CHIP) Fee-for-Service programs, Medicaid and CHIP managed care plans, and Qualified Health Plan issuers on the Federally Facilitated Exchanges to streamline prior authorization (PA) processes to reduce physician practice burdens and prevent patient care delays. The American Medical Association (AMA) expects the rule to align with their PA reform campaign, which is a pillar of the AMA Recovery Plan for Physicians. If finalized, these prior authorization policies would take effect January 1, 2026, with the initial set of metrics proposed to be reported by March 31, 2026. #### **Prescription Opioid Settlement Distribution Commission Grant Application**

The Prescription Opioid Settlement Distribution Commission (POSDC) is now accepting applications via the newly launched website. Delawareans will be able to submit applications through the website for funding. The current available funding for the Commission is approximately \$3 Million. The 2022 Phase 1A Application will be open November 30, 2022 – December 31, 2022. Applicants may apply to be considered for grants and intragovernmental transfers of \$100,000 or less from the Prescription Opioid Impact Fund established under 16 Del. C. § 4803B and/or the Prescription Opioid Settlement Fund established under 16 Del. C. § 4808B. Applications can be submitted on the POSDC website. #### **HHS Postpones Enforcement of Good Faith Estimates**

Under the No Surprises Act, physicians and other health care professionals and facilities are required to provide good faith estimates to uninsured, out-of-network, or self-paying patients for services offered when scheduling care or when the patient requests an estimate. According to new guidance released by the Department of Health and Human Services (HHS) last Friday, the Centers for Medicare & Medicaid Services (CMS) will not begin enforcing the No Surprises Act requirement to deliver good faith estimates. Enforcement was to begin on January 1, 2023, however HHS is extending enforcement discretion, pending future rulemaking, for situations where good faith estimates for uninsured, out-of-network, or self-pay individuals do not include expected charges from co-providers or co-facilities.
