# Delaware has a NEW Medicaid Payer; Deadline to Sign Up is Fast Approaching!

The Division of Medicaid and Medical Assistance (DMMA) has approved a third Medicaid payer for the State of Delaware. Delaware First Health, a subsidiary of their parent company, Centene, is a new Medicaid payer that is now entering the Delaware market. Delaware First Health will now be 1 of 3 Medicaid Payers in Delaware (in addition to Highmark Health Options and AmeriHealth Caritas). Delaware First Health is working hard to develop a physician network in preparation for Medicaid Open Enrollment which is October 1, 2022. If your practice accepts Medicaid, you will likely want to become a participating provider ASAP before the approaching deadline (10/1). ### **Tell Congress to Cancel the Cuts!**

Physicians are facing another round of Medicare payment cuts by the Centers for Medicare and Medicaid Services (CMS). Unless Congress acts by the end of the year, physician Medicare payments are planned to be cut by 8.42 percent in 2023 which would severely impede patient access to care due to the forced closure of physician practices and put further strain on those that remained open during the pandemic. ## **CDC Updates Masking Guidance for Health Care Facilities**

Last Friday, the Centers for Disease Control and Prevention (CDC) issued updated guidance regarding infection prevention and control for health care personnel during the COVID-19 pandemic. The updated guidance provides health care facilities with some flexibility in using COVID-19 community transmission levels and the risk of transmission within their own facilities when determining needs for specific types of masking and personal protective equipment. However, at high community transmission levels or increased risk of transmission within a facility, CDC continues to recommend source-control masking and respiratory personal protective equipment for everyone in a health care setting. With the current levels of community transmission in Delaware and the potential for increased transmission of COVID-19/influenza as the fall and winter approach, along with staffing difficulties many facilities are facing, the Delaware Division of Public Health continues to encourage source-control masking and respiratory protection within health care facilities. Due to the complicated nature of the PSLF program established in 2009, the department of education is allowing borrowers to fix mistakes on their initial PSLF applications. Until October 31st, borrowers may apply for forgiveness and get extra payments towards the loan forgiveness counter, despite not meeting the initial requirements.
