Amazon Launches Prescription Drug Program

Amazon has introduced a new prescription drug subscription program for Prime members, called RxPass that will ship generic medications to customers' homes for a flat monthly fee of \$5. The \$5 charge includes the cost of delivery and is added to Prime customers' existing monthly subscription fee. Medications can be delivered on either a monthly or quarterly basis depending on the prescription requirements. A full list of generic medications covered by the RxPass subscription can be found at https://pharmacy.amazon.com/rxpass. The program does not require insurance coverage and customers who are enrolled in Medicare, Medicaid, or any other government health care program are not eligible for RxPass but can still use government insurance to fill prescriptions which has a range of generic drugs, some priced as low as \$1 for a 30-day supply. The benefit of this new program will vary by customer. Amazon Pharmacy obtains provider information from the Sure Scripts Directory. Mandatory Reporting Training for Medical Professionals

Delaware law requires that, in order for medical professionals to renew their license, they must attest that they have completed the mandatory reporting training. This training must be completed before every medical license renewal. Training can be completed at https://tinyurl.com/bdfsmbjy. Once completed, medical professionals can then reapply for licensure through the Division of Professional Regulation's website at https://delpros.delaware.gov/OH_HomePage. If you are having difficulty accessing or logging in to the site, the state has provided a step-by-step self-registration guide (https://tinyurl.com/nbmfwzb6) to assist you. **MSD does not have access to DELPROS.** Please contact the State for questions.

FDA Proposing Annual COVID Vaccinations

The U.S. Food and Drug Administration (FDA) on Monday proposed a simplified approach for future vaccination efforts, allowing most adults and children to get a once-a-year shot to protect against the mutating virus. Those with weakened immune systems and also small children may require a two-dose combination, but data would need to be studied to determine whether a single shot or two dose series is needed. Using a similar approach in the annual flu vaccine development, the FDA proposes that it would be determined annually which strains to target by the early summer, to allow time to produce and launch the updated vaccine prior to the fall.
