## **Mandatory Reporting Training for Medical Professionals**

The 2023 Mandatory Reporting Training for Medical Professionals became available on January 1, 2023. Licensed physicians must take the 2023 Mandatory Reporting training even if they recently completed mandatory reporting training. This training must be completed before every medical license renewal. Physicians are required to attest to completing the training on their license renewal application. ### Daptomycin for Injection (500 and 350 mg/vials) Recall

The U.S. Food and Drug Administration (FDA) announced that Accord Healthcare is recalling a single lot of Daptomycin for Injection 500 mg/vial, and Daptomycin for Injection 350 mg/vial product contained in cartons imprinted with lot # R2200232 Exp: 01/2025 to the consumer/user level. This product is being recalled because Accord received a product complaint report from a hospital pharmacy that vials labeled as "Daptomycin for Injection 500 mg/vial" were found in cartons labeled as "Daptomycin for Injection 350 mg/vial". ### Omicron Subvariant XBB.1.5 Becoming Dominant in US

A new version of omicron has taken hold in the U.S., according to the most recent data from the Centers for Disease Control and Prevention (https://tinyurl.com/2p87987r) (CDC). The subvariant of omicron, named XBB.1.5, has raised concerns about another potential wave of COVID-19 cases following the busy holiday travel season. The CDC projected that about 41% of confirmed U.S. COVID-19 cases are caused by the XBB.1.5 strain, up from 20% projected just a week prior. In the Northeast, about 75% of confirmed cases are reported to be XBB.1.5. The COVID Omicron XBB.1.5 variant is rapidly becoming dominant in the USA.
