#### **DPH Announces Closure of COVID-19 Call Centers**

The Delaware Division of Public Health (DPH) announced the closure of the COVID-19 call center and the vaccine call center due to a low volume of calls and re-allocation of personnel to other critical health work. The Call Centers' last day of operation was Tuesday, January 31. Delawareans may still access critical COVID-19 information on the website at de.gov/coronavirus, where questions can be submitted via the contact form at coronavirus.delaware.gov/contact. # **National COVID Emergency Declarations to End**

President Biden announced he will end both national emergencies for addressing COVID-19 on May 11. The \$1.7 trillion spending package passed last year ended a rule that barred states from terminating Medicaid services, a move that is expected to see millions of people lose their coverage after April 1. The costs of COVID-19 vaccines are also expected to skyrocket once the government stops buying them, with Pfizer saying it will charge as much as \$130 per dose. Once the emergency expires, people with private insurance will have some out-of-pocket costs for vaccines, tests and treatment, while the uninsured will have to pay for those expenses in their entirety. # **Surprise Billing Rule Challenged by Texas Med. Assoc.**

The No Surprises Act bans surprise medical bills and would require payers and physicians within 30 days to go into arbitration for settling out-of-network charges. In October 2022, the initial administrative fee for the arbitration process was established as \$50 for 2022 and 2023. However, in December 2022 it was announced that the fee would increase to \$350 for 2023 to help cover rising costs of the arbitration process. The Texas Medical Association (TMA) filed its fourth legal challenge in the US District Court for the Eastern District of Texas regarding implementation of the No Surprises Act. # Positive COVID Test No Longer Required for COVID Pills

The US Food and Drug Administration (FDA) revised the emergency use authorization (EUA) indicating physicians and pharmacists will no longer need to require a positive COVID test to prescribe Paxlovid and Lagevrio (molnupiravir), oral COVID-19 therapies developed by Pfizer and Merck. Previously, the treatments were only indicated for those who tested positive for COVID-19 and were at risk of developing the severe form of the disease. The FDA continues to recommend, however, direct viral testing to help diagnose COVID-19 patients who are eligible to receive the treatments.
