Blood Bank Declares First Blood Emergency of 2023

The Blood Bank of Delmarva (BBD) declared its first blood emergency of 2023. The blood emergency is due to several evolving factors, including school breaks, cold and flu season, and the lingering effects of COVID-19. In January 2023, BBD received 1,000 fewer donations than the previous January. The number of blood donations still are not back to pre-pandemic levels. Compounding the problem is a continued lag in first-time and youth donors, which remain one-third below (33%) pre-pandemic levels. BBD needs all blood types, including 0 negative and 0 positive blood. In addition to whole blood donors, platelet donors are urgently needed. With a shelf life of just five days, BBD relies on dedicated platelet donors to help patients undergoing chemotherapy, those with bleeding disorders, new mothers, and more. Recreational Marijuana Bills Pass the House

Bill one of a two bill effort to make recreational marijuana legal in Delaware passed the House of Representatives on Tuesday. It has been assigned to the Health and Social Services Committee in the Senate. House Bill 1 (<u>https://tinyurl.com/bdefdzdj</u>) would eliminate all penalties (including a civil penalty; adult use, possession and sharing of personal use quantities; and fines for possessing or using "marijuana accessories") for possessing 1 ounce or less of marijuana by those 21 years of age or older. The legalization of recreational marijuana would be accomplished through enactment of House Bill 2 (<u>https://tinyurl.com/ycx39yvx</u>) (the Delaware Marijuana Control Act), which would establish the framework for marijuana sales. HB 2 would also create the Delaware Marijuana Control Act Oversight Committee to coordinate the statute's implementation and review its impact on the public health and safety. HB 2 with House Amendments 1 and 2 has been sent to the Senate Health & Social Services Cmte.

Spring Forward – Daylight Saving Time Begins March 12

Daylight Saving Time begins on Sunday, March 12, 2023, at 2:00 AM. On Saturday night, clocks are set forward 1 hour (i.e., losing one hour) to "spring forward."
