REMINDER: 2023 is a Medical Licensure Renewal Year

The deadline to renew medical licenses is March 31, 2023. Prior to your licensure renewal, you must take the Mandatory Reporting for Medical Professionals education. Failure to complete the training will delay the renewal of your medical license. There is a specific course approved for meeting this requirement. To complete the education, go to https://tinyurl.com/yx434tsx to create an account or if you have an account, to login. Once you have completed the course, you can reapply for licensure through the Division of Professional Regulation website at https://tinyurl.com/mtephtwp. MSD does not have access to DELPROS. If you have questions or need technical assistance, please contact the State of Delaware.

DEA Letter on MATE Act Training Requirements

The US Drug Enforcement Administration (DEA) issued a letter this week to DEA-registered practitioners outlining the training that will meet the requirements of the Medication Access and Training Expansion (MATE) Act that was passed as part of the Consolidated Appropriations Act of 2023. The Act requires new or renewing DEA registrants, as of June 27, 2023, to have completed a total of at least eight hours of accredited continuing education on the treatment and management of patients with opioid or other substance use disorders before renewing their licenses. The letter also states that physicians will be able to simply check a box on their DEA registration application or renewal form indicating that they have satisfied this training requirement. Delaware Drinking Water Not Impacted by Chemical Spill

Philadelphia water officials have been monitoring water quality closely following a chemical spill last Friday. A leak late Friday evening at the Trinseo Altuglas chemical facility in Bristol Township spilled between 8,100 and 12,000 gallons of a water-based latex finishing solution. Officials said it is non-toxic to humans, and no known adverse health effects have been reported in the county. The Division of Public Health (DPH) on Sunday shared that Delaware drinking water has not been impacted by the chemical spill in a tributary of the Delaware River in Bristol, PA. "Delaware's drinking water has not been impacted by the spill in Pennsylvania," said DPH Interim Director Dr. Rick Hong. For more information visit https://tinyurl.com/2p8enrbu.
