#### AMA Annual Meeting Adjourns, Delaware Has Success!

MSD'S RESOLUTION ADOPTED! For the Delaware Delegation attending the 2023 American Medical Association (AMA) Annual Meeting, the highlight of the meeting was the adoption of Delaware's resolution submitted on social media and gun violence. Emanating from a resolution adopted by MSD Council at its Annual Meeting in November 2022, "Minimizing the Influence of Social Media on Gun Violence" directs the AMA to call upon social media sites to aggressively remove postings glorifying the use of guns and gun violence, work with social media sites to provide educational content on the use of guns and inherent dangers, and creates new AMA policy recommending social media sites continuously update and monitor algorithms to detect and eliminate information on guns that influences viewers to act violently. #### **Prior Authorization Bill Introduced**

Last Thursday, Senate Bill 10 (SB 10) was introduced by Senate Majority Leader Bryan Townsend and State House Majority Whip Melissa Minor-Brown. The "Delaware Pre-Authorization Reform Act of 2023" seeks to reform the prior authorization process by: The bill shortens the timelines for the determination of pre-authorization requests and notification to the health care professional. By January 1, 2024, insurers and others must accept and respond to electronic pre-authorization requests through the same platform as the electronic request was submitted.
