In an effort to keep Delaware's medical community current on the latest information regarding the coronavirus crisis, the Medical Society of Delaware is sharing the following:

# DPH Announces 88 New COVID-19 Cases and Three Additional Deaths

According to the Delaware Division of Public Health (DPH), 88 new Delawareans have been diagnosed with COVID-19, taking the total number of lab-confirmed cases to **2,014**, including **208** who are hospitalized, **48** of whom are critically ill.

**Forty-six** individuals have died due to COVID-19 in Delaware,**28** of whom were residents of long-term care facilities. The most recent deaths involved:

- 83-year-old female from Sussex County, hospitalized long-term care resident
- 53-year-old female from Kent County, hospitalized
- 46-year-old male from New Castle County, hospitalized

# Information to Share with Patients Being Tested for COVID-19

### Governor Asks for Stricter Measures for Long-Term Care Facilities

Delaware Governor John Carney has issued the 11th modification to his State of Emergency declaration, requiring stricter guidelines to prevent COVID-19 infections in nursing facilities and other long-term care facilities. The order requires nursing facilities to immediately ensure they are in full compliance with the Public Health Authority guidance related to COVID-19. Nursing facilities must check Division of Public Health (DPH) guidance at least daily to ensure they are complying with the most current guidance and adjust their policies, procedures, and protocols accordingly. <u>Read more</u>.
