

#### COVID-19 UPDATE 4-24-2020

In an effort to keep Delaware's medical community current on the latest information regarding the coronavirus crisis, the Medical Society of Delaware is sharing the following:

### DPH Announces 134 New COVID-19 Cases and Eight Additional Deaths

According to the Delaware Division of Public Health (DPH),134 new Delawareans have been diagnosed with COVID-19, taking the total number of lab-confirmed cases to 3,442, including 277 who are hospitalized, 63 of whom are critically ill.

**One hundred** individuals have died due to COVID-19 in Delaware with ages ranging from 32 to 103 years old. The most recent deaths all involved individuals with underlying health conditions.

- 69-year-old male from New Castle County, hospitalized
- 71-year-old male from New Castle County, hospitalized
- 96-year-old female from New Castle County, long-term care facility
- 102-year-old male from New Castle County, long-term care facility
- 54-year-old female from Sussex County, long-term care facility
- 79-year-old female from Sussex County, hospitalized
- 87-year-old male from Sussex County, hospitalized

# Bayhealth / ChristianaCare Using Plasma Therapy on COVID-19 Patients

Bayhealth and ChristianaCare, two of the state's largest health care systems, are now using plasma donated by recovered COVID-19 patients to treat active COVID-19 patients. Convalescent plasma therapy involves transferring antibodies from one individual to a blood-matched recipient in order to fight an infection. Both hospitals systems have partnered with the Blood Bank of Delmarva to promote and receive donations. ChristianaCare recently treated their first COVID-19 patient using convalescent plasma therapy.
