



## CORONAVIRUS SCREENING QUESTIONS - EASTERN OPERATIONS

1. Do you have a diagnosis of Coronavirus or is the reason for your exam to rule out Covid-19 or Coronavirus??  Yes  No

**If No:**  
Ask Question 2

**If Yes:** Pend the appointment and advise the patient

"We will be happy to set up your appointment, but ask that you first have a doctor determine you are virus free and your symptoms have resolved before selecting a date and time."

- Our centers are not equipped with negative pressure procedure rooms, therefore we cannot schedule patients who have or may carry the COVID-19 Coronavirus.
- We must be cognizant of the safety of everyone in our centers, including other patients who may have compromised immune systems.
- It is important that you contact your referring physician for further instructions regarding whether or not you can wait to reschedule or need to be referred elsewhere.

2. Do you have any two (2) of these following three (3) symptoms:  Yes  No

- A current fever or a fever within the past 24 hours,
- A new cough, or
- A new or recent onset of shortness of breath?

**If No:**  
Ask Question 3

**If Yes:** Pend the appointment and advise the patient

3. In the past 14 days, have you:  Yes  No

- Travelled internationally to an area affected by widespread Coronavirus,  
*This includes: China, Iran, Malaysia, South Korea or Europe (Austria, Belgium, Czech Republic, Denmark, England, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal, Slovakia, Slovenia, Spain, Sweden, Switzerland, Monaco, San Marino, Vatican City)*
- Had direct exposure to someone with confirmed Coronavirus, or
- Been told to self-quarantine?

**If No:** Schedule and advise the patient

In an effort to help prevent the spread of Coronavirus at this time, we are asking all patients to please refrain from bringing any guests into our centers. If you must bring someone with you for assistance, please limit this to one person and please make sure they do not have any flu-like symptoms or have possibly been exposed to Coronavirus within 14 days of your appointment. Please understand that sick guests will be asked to leave.

**If Yes:** Schedule the appointment more than 14 days out and advise the patient

"We will be happy to schedule you for a date after which a 14-day incubation period has passed, provided that you do not develop or become exposed to Coronavirus symptoms during that time."
